- The Board of Commissioners of the Aqaba Special Economic Zone Authority, in its decision No. (1190), Session No. (67/2019) held on 17/12/2019, decided to approve the Explanatory Appendix No. (1) of the Aqaba Container Terminal Service Charges Notification for the year 2019, as follows:
- 1. This Explanatory Appendix shall be considered an integral part of the Aqaba Container Terminal Service Charges Notification and shall be read along with it as one unit.
- 2. A shifting charge shall be applied to all import containers for value-added services provided by the Company (ACT) to security authorities, customs and other governmental departments within the Aqaba Container Terminal (including but not limited to providing space and facilitating operations), as part of the requirements of compliance with the International Ship and Port Facility Security Code (ISPS Code), which applies to all ports, terminals and shipping lines all over the world.
- 3. A double shifting charge shall be applied in the event that the Exporter loads an empty container from the Aqaba Container Terminal yards which will appear as an Equipment Delivery Order or ("EDO") instead, according to the appropriate common term used in the maritime industry.
- 4. The customer shall be granted a free storage period (free days) of 7 days for the full export containers and the full transshipment containers.
- 5. The Company shall have the right to recover the costs it incurs, from the responsible party, for the purpose of repairing the damage to the port, its equipment, infrastructure, or superstructure and / or in the event of implementing any safety, security, health protection or environmental protection measures to control the situation after the occurrence of an incident or accident that is caused by the responsible party (sweeping, cleaning, pollution removal, CCTV surveillance).
