Terminal Safety Rules

Over the Road Trucker

As a responsible and sustainable business, the success of our operations and the safety of our workforce go hand in hand. Our goal is to ensure we have safe operations. Safety is not bolted on to our business – we integrate it into our normal day-to-day operations.

- Drivers must STAY in truck cab unless in approved, designated area. Refer to link: ([Truck driver safety video](#))
- Must wear seat belts while operating vehicle
- Must wear a high-visibility, reflective vest.
- Must check in with security upon arrival
- Must have a Valid TWIC
- Cell phone use while driving is prohibited.
- No walking or driving in between container stacks or rows
- Are not permitted on the highline (dock), or road nearest to the dock where the vessel is working.
- Are not permitted to enter rail section of the terminal
- Must drop off and pick up all chassis from the chassis pit.
- Are expected to comply with all traffic signs and terminal security instructions.
- Speed limit is 15 mph
- Do not drive behind TH working in container stack/rows, or any other blind spots,
- Maintain a safe distance from other vehicles, no tailgating
- Must come to a complete stop at all posted and painted stop signs
- Only use designated restrooms
- No unauthorized passengers (passengers must meet facility ID requirements) or pets/animals
- No photography of any kind, without the express written consent of APM Terminals
- No weapons are authorized on the facility, even if you have a concealed weapon permit
- Are subject to random screening of your vehicle and contents
- Report any accidents or injuries to APM Terminals management immediately
- Drivers that attempt to utilize CUT's Terminal EXIT that are conducting a transaction from APMT's terminal will be banned.
- Picking the Wrong chassis size for a Modernized Facility transaction is prohibited
- Failure to unlock pins for a Modernized Facility transaction is prohibited
- Pressing the Estop button for anything other than an Emergency is prohibited.

- Drivers found in violation of any rules may be banned until they [attend our S.T.E.P. class.](#)

Vendors/Contractors

- Must check in with security upon arrival
- Must have an approved SOP or PTW on file prior to commencing any work
- Must abide by all requirements listed in Permit to Work and/or SOP
- Responsible for maintaining safety in the assigned work space
- Must properly wear Safety Vest at all times
- Must have Hard Hat on the dock
- Speed Limit is 15 mph
- Must properly wear seat belt while operating a vehicle
- Cell phone use while driving is prohibited.
- No walking or driving in between container stacks or rows
- Do not drive behind equipment working in container stack/rows, or any other blind spots
- Maintain a safe distance from other vehicles, no tailgating
- Must come to a complete stop at all posted and painted stop signs
- Only use designated restrooms
- No unauthorized passengers (passengers must meet facility ID requirements) or pets/animals
- No photography of any kind, without the express written consent of APM Terminals
- No weapons are authorized on the facility, even if you have a concealed weapon permit
- Must have your valid TWIC and Facility ID to enter and remain on the facility
- Are subject to random screening of your vehicle and contents
- Must comply with all requests given by terminal security personnel
- Report any accidents or injuries to APM Terminals management immediately
