She has also worked in Anand, Bharuch & Vadodara as a Collector, as a District Development Officer (DDO) in Gandhinagar and Anand, and as Deputy Secretary – Energy and Petrochemicals Department, Government of Gujarat.

In 2012, Mrs. Aulakh was honoured by the Election Commission of India for her outstanding contribution by implementing the best electoral practices at Bharuch during her tenure as the District Election Officer.

Mrs. Aulakh is not related to any Director of the Company.

The Company shall continue to comply with the requirements under Regulation 17 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, regarding the composition of Board of Directors with appointment of Mrs. Aulakh as its Non Executive Non Independent Director.
