Each member of our Senior Management Team is responsible for managing all HSSE risks, so that they are clearly defined, understood and communicated, so that HSSE performance is fully integrated into business objectives and the necessary resources are made available to ensure full compliance with HSSE Policies and all legislative and contractual requirements.

All managers of Vado Gateway are responsible for:

- Spread within the company, through a constant awareness-raising action, a culture where everyone assumes personal
  responsibility in the management of HSSE risks according to their role and the HSSE objectives assigned;
- Ensure that every incident is recorded on the GIZMO system (Fatal5.com) and analyzed, in order to define and take appropriate corrective actions;
- 3. Learn from internal incidents and those shared by the Group, promoting Learning Teams and sharing learned lessons;
- 4. Ensure that all employees contribute to the programs and actions defined by the company for the protection of the environment and for the improvement of HSSE performance;
- 5. Ensure that procedures and operating instructions are shared with the front line and kept aligned with the operational reality, through constant process confirmation;
- 6. Reduce environmental impacts, with particular attention to the management of emissions produced, for the protection of the territory and the Interested Parties;
- 7. Conduct all activities, with regard to the health and safety of workers, and environmental protection, applying the company management system, in compliance with ISO 45001 and 14001;
- 8. Promote the involvement and consultation of workers and their representatives in the main company processes, with particular regard to safety prevention and continuous improvement;
- 9. Involve contractors and external collaborators, in the protection of health and safety at work and in environmental protection, disseminating the Policy, systems and objectives, ensuring cooperation and coordination at every stage of the contractual relationship;
- 10. Pursue a constant increase in health and safety performance through a punctual organization of work and the provision of adequate economic, human and technological resources;
- 11. Perform periodic audits and inspections on activities with the aim of measuring compliance with defined HSSE policies, procedures and objectives;
- 12. Identify and prevent any environmental, health and safety emergency and control any emergencies through specific plans;
- 13. Identify and control potential security risks by implementing specific organizational and management measures shared with the competent authorities.
